FEDERAL GOVERNMENT STARES AT ANOTHER BUDGET DEADLINE

On January 25th, the 35-day partial federal government shutdown ended. Congress and the President agreed to a stopgap bill to reopen the government for three weeks to allow for negotiations to take place to approve an appropriations bill that both parties could agree on. The President has stated that if Congress fails to reach a deal by **February 15**, he would shut down the government again or declare a national emergency and use military funding to build the wall. Given the wide Republican opposition to the President declaring a national emergency for this purpose, another shutdown is a real possibility.

The result of the stopgap bill is that the partial government shutdown agencies are currently funded through Feb. 15. Roughly 75% of the government is funded as their appropriation bills were passed. The approximate 25% shutdown agencies include the Department of Interior, but not the Bureau of Reclamation, as they are primarily funded out of the Energy & Water Appropriations bill that was enacted, and the Department of Transportation.

The impact of this partial shutdown was starting to be felt by the wider construction industry and undoubtedly there are projects in design / permitting stages that have been delayed as a result. CWCC Members are asked to share relevant information related to impacts your members experienced during the partial shutdown, if any. CWCC will continue to monitor the situation and will keep you up-to-date.

FY 19 APPROPRITATIONS BILLS

The FY 19 Interior Appropriations bill is still pending but will include funding for the CWSRF and SDWSRF.

The FY 19 Energy and Water Appropriations bill (\$147 billion total) was enacted and included an appropriation of the final \$20 M authorized funding for the WIIN Act recycled water grant program. The appropriations bill also includes \$1.54 billion for Harbor Maintenance Tax (HMT)-funded work, The bill also increases funding amounts and allows new starts in both the Corps of Engineers' investigations (studies) and construction accounts.

DRAFT 2019 COALTION PRIORITIES

The Coalition's proposed priorities for 2019 include supporting a mega-infrastructure bill with robust funding for water; reauthorizing the WIIN Grant program with an increased program authorization; supporting Clean Water Act reauthorization; supporting earmarks for water projects; and, advocating for increased CWSRF and SDWSRF funding and water funding in general in the FY 20 appropriations process. Many of these priorities are carried over from 2018. Any input on these priorities from members is welcome. We ask that input be shared by the end of February to Dan Kennedy (kennedy@utcanj.org). These priorities will be used for materials for the Fly-In in early April.
